WHEREAS, the East Cleveland City School District will contract with Alpha Education Inc. to provide professional development, consultation and coaching services on Restorative Practices and system alignment for teachers and administrators in grades 6 - 12 for the school 2020-2021 school year; and

WHEREAS, the 45 hours of professional development will provide training on the fundamental theory and practices for engaging with students, staff and parents in the school setting and how to set high expectations while being supportive and utilize the most effective methods to resolve common conflicts, and

WHEREAS, the 45 coaching/consulting hours will provide direct support with school staff in creating systems to support restorative practices; therefore, be it

RESOLVED, that this Board authorizes the Treasurer to encumber and pay an amount not to exceed \$15,750.00 for said services from the IDEA Fund-516.

2. RESOLUTION TO AUTHORIZE A CONTRACT WITH AND PAYMENT TO HILLARY GOLDTHWAIT FOWLES, PH.D, ATP

WHEREAS, the East Cleveland City School District will contract with Hillary Goldthwait Fowles Ph.D., ATP to provide professional Intervention Specialist, Psychologists, Speech and Language teachers, Occupational Therapists and Physical Therapists in grades K -12, and
